Dear reader,

In this edition, we highlight governments unwavering support to the Rural Electrification Programme. The support reinforces the work of REA in ensuring we meet the mandate of increasing access to electricity in rural areas. Her Honour the Vice President of the Republic of Zambia Mutale W.K Nalumango flagged off the implementation of rural electrification projects for 2023. This event was significant as it strengthened governments development agenda through the rural electrification programme.

The significant funding towards the 2023 budget amounting to K743m underscores the resolve by government to stimulate rural development. Given that electricity is a catalyst to development, governments support resonates with our resolution for 2023.

Under this year's Work Plan and Budget, the Authority is implementing 85 new rural electrification projects comprising 62 Grid Development Projects (GDPs) and 23 Renewable Energy Project (REPs) distributed across all the ten provinces of Zambia targeting to connect a total of 88,428 beneficiaries comprising 161 Schools, 161 Rural Health Centres (RHC), 26 other public facilities, 18 Markets, 98 Palaces and 14,738 Households.

Veep flags off REA projects

Republican Vice President Mrs. W.K. Mutale Nalumango has flagged off implementation of the 2023 projects to be implemented by the Rural Electrification Authority (REA).

During a ceremony held at Kamisamba Health Post in Zambezi District, the Vice President said the government was committed to improving the standards of living for people in rural areas. "This year, Government increased funding to REA to over K743 million to accelerate rural electrification projects," she said. Mrs. Nalumango said electricity was critical to unlocking numerous socio-economic potentials in rural areas.

"Western and North-western Provinces are endowed with mineral resources. Therefore, taking energy to these areas would act as a catalyst for development, as most investments require reliable sources of energy," she said.

The Vice President also urged investors to support government efforts to accelerate development through corporate social responsibility initiatives.

REA Chief Executive Officer, Linus Chanda, said his institution was determined to provide reliable electricity to rural areas in the country through connection to the national grid and off-grid systems.

"In order to unlock the economic potential in rural areas, we remain committed to ensuring that reliable electricity is provided," Eng. Chanda said.

As part of the 2023 workplan and budget, the Authority has commenced the implementation of 62 grid development projects and 23 off-grid energy projects.

This is expected to translate into 15120 beneficiaries, comprising 161 schools, 98 chief palaces, 18 markets, 14738 households, 161 rural health centres and 26 other public facilities.

The flagging off of REA projects took place on 23rd September, 2023, at Kamisamba Health Post in Zambezi District in North Western Province. The activity took place on the sidelines of the CAPAH Expo, which was held in Zambezi from 25th September to 29th September, 2023.

REA Signs 28 more 2023 project contracts



The Authority has already signed 44 contracts out of a targeted 85 contracts.

The Rural Electrification Authority (REA) has signed a second batch of 28 project contracts to be implemented under the 2023 workplan and budget.

This brings the total number of contracts to 44, following the prior 16 contracts that were signed in the first and second quarters.

Speaking at the signing ceremony held at Golden Peacock Hotel in Lusaka, Acting Chief Executive Officer, Eng. Alex Mbumba, said that the Authority was implementing more projects following the increase in funding from Government from K362 million in 2022 to K743 million in 2023.

“The Authority has received more funding from the Government that will allow us to fast-track electrification in the communities we serve. The twenty-eight contracts we are signing today will be implemented at a total cost of K168,542,764.

This brings the total cumulative contract sum for the 44 signed contracts to K348,569,738.48. Through these projects, we will electrify 56 schools, 24 rural health centres and 4,395 households, translating into 26,370 beneficiaries.

These contracts are expected to create about 1200 direct jobs.” Eng. Mbumba said.

The contract signing ceremony is the first step in handing over project sites to the respective contractors. Through this event, contractors were oriented on the expectations of the Authority and community during project implementation.

The signing ceremony was held at the Golden Peacock Hotel in Lusaka on Thursday 10th August 2023.

Chishi island habitants anxiously need electricity

Chief Mbulu of Chishi Island in Chifunabuli District in Luapula Province has called on the Rural Electrification Authority (REA) to expedite the electrification of his chiefdom. The traditional leader said it was gratifying to note that Chishi Island was earmarked for electrification.

“We would like to thank REA for bringing electricity to this place; we have never had electricity in our entire lives. Electricity has the power to transform communities and we cannot wait to experience positive change,” he said.

Speaking when REA Chief Executive Officer Eng. Linus Chanda paid a courtesy call on him, Chief Mbulu said the supply of electricity to the area is expected to boost the existing economic activities on a microscale, such as crop farming, retail trading and fishing.

Eng. Chanda said the Chishi Island project was expected to have social and economic benefits for a catchment population of 8,000.

“It targets an initial clientele of 2600, which includes standard connections, private connections, and grass

thatched houses, through the provision of Ready Boards,” he said.

Eng Chanda said the availability of electricity in the area will consequently make it possible to set up new businesses in the area, such as electric hammer mills for processing maize-meal, poultry, entertainment centres, welding, hair salons and barbershops, among others.

He added that staffing levels at public institutions are also expected to greatly improve with the availability of power, as public workers will be able to use electric appliances such as television sets, radios, cookers, fans, computers, and other entertainment systems, thereby motivating staff to stay in rural areas. Earlier, Chishi Secondary School head teacher Mathews Machona said having electricity at the school will help in teacher retention.

“In some cases, some teachers have refused to come and work on Chishi Island because of a lack of electricity,” he said.

Mr. Machona, on the other hand, said the pupils will have extended hours of studying, adding that currently pupils cannot study at night because it is dark.

Women led companies come to the stage

It's no longer a man's world as REA awards three women contractors. Getting more women into male-dominated industries has for some time now been the nucleus of public debate in many industrialised countries, of which Zambia is not an exception. To help bridge the gender gaps, Government has been implementing the National Gender Policy, which ensures the attainment of gender equality in the development process by redressing the existing gender imbalances.

It also provides for equal opportunities for women and men to actively participate, contribute to their fullest ability and equitably benefit from national development.

In support of the National Gender Policy, the Rural Electrification Authority (REA) has operationalised its gender policy by deliberately allocating three of these projects to women-owned companies with a view to mainstreaming gender in its operations. The three beneficiaries are Jamashu Enterprises Limited, Zariah Investment Limited and Miyomuri Construction and Engineering Limited.

On 10th August, 2023, REA hosted a contract signing ceremony for batch two of the 2023 projects at Golden Peacock Hotel, where Acting Chief Executive Officer (CEO) Eng. Alex Mbumba was the guest of honour. Eng. Mbumba said the Authority is proud that there are some women contractors who decided to bid. The CEO

challenged the three female contractors to ensure that they prove themselves so that more women can be considered for future projects.

“It is also worth noting that the authority has further operationalised its gender policy by deliberately allocating three of these projects to women-owned companies with a view to mainstreaming gender in its operations,” he said. And speaking at the same event, Director Strategy Planning, Mrs. Jacqueline Musonda, said the Authority will support the women on condition that they successfully implement the projects.

Mrs. Musonda urged the women contractors to ensure they prove themselves to show that they are capable of implementing engineering projects that are mostly male dominated.

“To our women folk, I am glad that we are smashing

the glass ceiling of the male dominated industry. As REA, we are gender sensitive and we will support you,” she said.

Mrs. Musonda said the contract awardees have a key role in transforming rural communities. It is worth noting that it is slowly becoming the norm to see women penetrating the male-dominated field.

However, some questions that beg answers are: Do women make a difference in a male-dominated field? Simply put, is having more women always for the better?

These and more questions are entirely up to the women contractors to prove to themselves that they too can do what the male contractors can do and can do it better.

Lubanda community to be powered

The Rural Electrification Authority (REA) has commenced the implementation of the electrification of the Lubanda community targeting Chief Chikaza Munyama of the Ila people in Itezhi-Tezhi District. This is the first phase of the project being implemented by Kalijee Construction Zambia Limited on behalf of the Authority at a cost of K12,091.923.40.

Speaking during the site handover ceremony, Acting Southern Regional Manager Eng. Newton Ndhlovu noted that the project will connect Chief Chikaza Munyama's Palace, the local court, the rural health centre, Lubanda Primary and Secondary Schools, the market and the surrounding communities to the national grid.

Eng Newton Ndhlovu said the Authority will work closely with the contractor to ensure that the project is completed within the timeframe stipulated in the contract.

"The Authority is working with the contractor to ensure the project is completed within five months. I encourage you to work with the contractor, as the success of this project depends on how we synergize our efforts.

"We are targeting to make seventy (70) initial connections of which nineteen (19) will connect government facilities and the remaining fifty-one (51) will connect private structures" he said.

"The infrastructure we are bringing here is yours and we encourage you to safeguard it and avoid vandalism. Our REA committee members are on the ground to give you more information on the project" Eng Ndhlovu added.

And speaking on behalf of the Area Member of Parliament Twaambo Mutinta, Itezhi Tezhi Council Chair Oliver Sitengu encouraged the community to use the electricity productively and assured them that he would continue advocating for projects that uplift the lives of the community members. "This project is a testament to Government's promise of universal access to electricity for all Zambians by 2030. Electricity is not just about connecting bulbs.

It will help us spur development in the province and improve service delivery in the health and education sectors.

Meanwhile, Chief Chikaza Munyama said he was happy that the Authority was supplying his chiefdom with electricity because it would accelerate development.

"Itezhi-Tezhi District is a rich strategic area and connecting our chiefdom to electricity supply will open it up for economic ventures. Our community has received this project with open arms, and we can assure you that anyone who is caught vandalising the project will be punished," he said. Under the 2023 workplan and budget, the Authority has targeted implementing eighty-three projects, of which sixty-two are grid development projects and twenty-one are solar projects.

The electrification project is part of a larger scope that includes electrifying chiefs in Itezhi-Tezhi District. The chief palaces that will benefit include Chief Shimbizhi and Chief Shezongo's chiefdoms.

The full scope of this project involves the construction of 118km of 33 kV and 21 km of 400V to supply power to the three chiefdoms at a total cost of K62,36,041.20. The project targets connecting 931 initial service connections, including public facilities and private structures.

The second and third phases will be implemented through the 2024 workplan.

Salamano project commissioned

Government has officially commissioned the Salamano Grid Intensification Project in Kitwe District, Copperbelt Province. The ceremony signified the handover of the project to Zesco Limited for operations and maintenance.

Delivering a keynote address on behalf of the Minister of Energy Eng. Peter Kapala MP, Copperbelt Province Permanent Secretary Augustine Kasongo said government through the Rural Electrification Authority (REA) had embarked on grid intensification projects such as Salamano grid intensification project in order to enhance electricity access at an affordable cost.

Honourable Eng. Kapala said the grid intensification technology under grid development was a timely intervention which had significantly accelerated electricity connections as it target densely populated communities where the electricity network already exists.

And speaking at the same occasion REA Chief Executive Officer Eng. Linus Chanda said the increase in Government funding to REA in the 2023 budget had given impetus to undertaking more life changing projects.

The Salamano Grid Intensification Project project was undertaken at a cost of 2.1 million kwacha.

“Developing electricity infrastructure targeting scaling uptake of electricity access was important for the development of the rural areas as it contributed to the attainment of government’s electrification targets as set out in the Eighth National Development Plan (8NDP), the vision 2030 and indeed the Rural Electrification Master Plan (REMP).”

The Minister also said the Salamano Grid Intensification Project targeted 203 standard connections with a provision of ready boards.

He also said he was gratified that the project was expected to bring about socio-economic benefits for a catchment population of 16,000.

“These options aren’t only expensive, but they are also a health hazard, impairing education, and emitting astonishingly high amounts of carbon into the atmosphere,” he said.

"As REA we know that the majority of the population in this area are living in total darkness. That is why we are here to distribute these solar lighting kits" he said. And Sipatunyana Ward Councillor Howard Munsanje commended REA for partnering with the NGOCC in the empowerment programme.

The people in the area will be able to enjoy effective communication as their phones will be charged using these kits," he said.

And NGOCC representative Joseph Nkausu encouraged the beneficiaries to safeguard the solar lighting kits. "These lights should not be sold; you must use them in your house for your benefit. Anyone who will sell the light should be reported to my office and we will take necessary action," he said.

Mr Nkausu encouraged the women from Nkolongozoya community to join women's' clubs so that they learn life skills and also benefit from various empowerment programmes such as the solar lighting kits which they received today.

And Nkolongozoya Women's Club Chairperson Selina Moono expressed happiness that they had been given the expensive lighting which they cannot afford to buy.

"We are so grateful to REA and NGOCC for the solar kits. We are in need of electricity but cannot afford to buy these lighting systems.

These solar kits will go a long way in easing our lives. I hope more women around the country like us also have a chance to benefit from this programme," she said. The Authority and NGOCC signed a partnership in 2018 aimed at increasing uptake of electricity in rural communities.

This partnership would create an enabling environment for productivity and improved quality of life, especially for women in project areas, by providing matching grants for.

A brighter tomorrow: Supplier engagement in rural development

The Rural Electrification Authority provides opportunities for suppliers of various goods and services to participate in the country's rural electrification programme. Suppliers can harness opportunities to participate in public procurement and contribute to government's developmental efforts, especially in rural electrification programmes, by following a strategic approach:

1. Stay Informed:

Suppliers should actively monitor and stay informed about upcoming procurement opportunities related to rural electrification projects. All governments, ministries, parastatals and spending agencies are required to publish their annual procurement plans prior to the commencement of all procurements.

These can easily be found on the Zambia Public Procurement Authority's (ZPPA) electronic government system.

2. Build Capacity:

Suppliers must have the necessary technical, financial, and operational capacity to meet the requirements of undertaking a contract. It is therefore important for prospective suppliers to invest in staff training, acquire relevant certifications, and ensure compliance with industry standards, regulations and social security requirements.

3. Network and Collaborate:

Collaboration can be a powerful tool. Suppliers can consider forming partnerships or consortiums with other companies or industry experts to enhance their combined capabilities. However, care must be taken when collaborating for Open National Bidding, which requires only Citizen Bidders to participate, unless a call for Citizen Bidders fails to secure an award of contract.

Building relationships with industry associations, local authorities, and government agencies can also provide valuable insights and opportunities.

4. Prepare Comprehensive Proposals/Bids:

When submitting bids for rural electrification projects, suppliers should ensure that their proposals/bids are comprehensive and address all regulatory, preliminary, technical, and financial aspects as embedded in the Standard Solicitation Documents used to call for Invitation of Bidders.

These embedded instructions for bidders will also include requirements for past experience through proof of successfully executed contracts. Merely stating the contracts undertaken without proof through practical or interim completion certificates for works and Goods Received Notes for supplies would often render a proposal or bid non-responsive.

The required value of experience may vary depending on the size and complexity of a project.

5. Emphasize Quality and Sustainability:

The Rural Electrification Authority has increasingly prioritised the quality and sustainability of its projects.

Therefore, suppliers should demonstrate their commitment to providing high-quality, reliable, and environmentally responsible solutions.

6. Legal and Ethical Compliance:

Suppliers must adhere to all legal and ethical requirements, including anti-corruption and transparency regulations. It is important to uphold a strong ethical code, which is essential to maintaining a good reputation in public procurement.

7. Bid on Multiple Projects:

Before bidding for contracts, kindly ensure that you are able to meet the stated requirements. However, diversify your opportunities by bidding on a range of rural electrification projects and/or lots under a tender.

Don't limit your options to a single project tender.

8. Seek Support and Guidance:

Local business support organisations and training by the Zambia Public Procurement Authority provide the necessary support to assist in preparing responsive bids. Scheduled trainings are held as called for by the Procurement Authority. These capacity building programmes can provide insight into the procurement process, regulatory requirements, and technical knowledge.

9. Patience and Persistence:

Public procurement can be a lengthy process, and success may not be immediate. Bidders should be patient and persistent, as it can take time to secure contracts. Most importantly, it is a bidder's right to follow up with a procuring entity and get debriefed on where its bid was unsuccessful in order to improve bid preparations for future tenders.

By following these strategies and being proactive in pursuing rural electrification projects through public procurement, suppliers can contribute to government developmental efforts while also benefiting from these opportunities to grow their businesses and make a positive impact on rural communities.

Community re-sensitisation and monitoring of community mobilisation activities

The Rural Electrification Authority (REA) undertakes of community mobilisation activities in its on-going on-grid and off-grid electrification projects through the Community Development section under Corporate Affairs.

The monitoring of community mobilisation activities is aimed at checking and appreciating what is happening in the project areas while attending to challenges or issues that are likely to affect the success of the projects.

The specific objectives of this activity are as follows;

- i. To monitor community mobilisation activities and inquire on the following;
 - Whether the established committee is still in existence.
 - What activities have been done by the

committees to encourage community participation in the project thus far.

- What the community had done so far to prepare for electricity connections (in terms of internal wiring, productive use of electricity, and any other issues highlighted during the initial project sensitization meetings).
- The benefits that have accrued to community members thus far.
- Whether there were any challenges or issues that were likely to negatively affect the project and attend to them through community re-engagement.

During the quarter under review, the section prioritised community sensitisation and monitoring of community mobilisation activities for on-going on-grid and off-grid electrification projects, where a total of twenty-six (26) projects were reached. These included five off-grid project areas and twenty-one (21) on-grid project areas.

Through these engagements, the section provides sensitisation activities for the project stakeholders by encouraging them to continue supporting the projects by preparing for electricity connections through the undertaking of internal wiring, renovating their structures, and providing security for the installed infrastructure.

The stakeholders were also encouraged to prepare for the engagements in various economic activities in line with the government's aspiration espoused in the Rural Electrification Act Number 5 of 2023.

The team also took time to engage with the community committees so as to get feedback on how prepared the community was and the various challenges affecting the projects. Through these engagements, the section assisted in resolving all the identified issues and further trained the committees on how to handle stakeholder issues.

It is envisaged that moving forward, the project implementation will move forward with full support from all the relevant stakeholders to ensure impactful outcomes.
