The Rural Electrification Authority has received funds from the Government of the Republic of Zambia towards the cost of Rural Electrification Projects and intends to apply part of this financing to payments under the Contracts for supply, delivery installation and commissioning of 4x20KWP solar mini grid power systems for Lunga Island -Phase 1.
2. The Rural Electrification Authority now invites sealed bids from eligible and qualified citizen and local bidders registered with National Council for Construction in Category E for the supply, delivery, installation, and commissioning of 4x20KWP solar mini grid power systems for Lunga Island-Phase 1. The project involves supply, delivery, installation, and commissioning of 4x20kWh solar power systems at the following points:

4. A complete set of Bidding Documents in English may be viewed by prospective bidders on the e-GP System. Participation in this tender shall be upon an electronic payment of a non-refundable fee of ZMW1,000.00 through the e-GP System (e-GP).
