**TENDER FOR SUPPLY, DELIVERY, AND INSTALLATION OF 2025 GRID
INTENSIFICATION POWER LINES - WOMEN RESERVED - LOTS 1-2 –
REA/ONB/W/7/2025**

1. The Rural Electrification Authority has received funds from the Government of the Republic of Zambia towards the cost of Rural Electrification Projects and intends to apply part of this financing to payments under the Contracts for Supply, Delivery, and Installation of 2025 Grid Intensification Power Lines, Lots 1-2.
2. The Rural Electrification Authority now invites sealed bids from eligible and qualified citizen and local bidders registered with National Council for Construction in Category E for the supply, delivery, and installation of 2024 Grid Intensification Power Lines for Lots 1 to 3 detailed as follows:

Lot	Description	District	Required Grade	NCC
1	Muyombe – Thendere	Mafinga	4,5,6	
2	Kambila	Lufwanyama	4,5,6	

3. Bidders are allowed to bid for one or more Lots. However, the award of contract will be restricted to one Lot per bidder except where there are not any other responsive bidders other than those who have been recommended for contract awards.
4. This tender is restricted to Women owned companies only. Bidders will be required to submit PACRA printout showing names of all Directors for the company. Bids received from non-Women owned companies shall not be considered.
5. Bidding will be conducted through the Open National Bidding (ONB) procedures specified in the Public Procurement Act of 2020 as read together with the Public Procurement Amendment Act 2023 and the Public Procurement Regulations of 2022 via the Zambia Public Procurement Authority's electronic Government Procurement System (e-GP).

6. A complete set of Bidding Documents in English may be viewed by prospective bidders on the e-GP System. Participation in this tender shall be upon an electronic payment of a non-refundable fee of K1,000.00 through the e-GP System (e-GP).
7. Submission of bids for this tender is by electronic means ONLY on the Zambia Public Procurement Authority e-GP System.
